

**\*Avery County Transportation (ACT) is a county agency that coordinates and provides general public transportation for Avery County residents. ACT does NOT provide emergency medical transportation of any kind.**

**\*Residents who need to ride may call ACT at least 24 hours ahead of time for any in county trips. Out of county medical trips will only be scheduled on the days set for the location you are going and need to be called in at least one week ahead of time. ACT cannot guarantee availability for out of county trips when called in. Please contact our office as soon as possible to cancel or change appointments.**

**\*ACT is committed to ensuring that no person is excluded from participation in or denied the benefits of the transit services we offer, consistent with the requirements of the Title VI of the 1964 Civil Rights Act, as amended. For more information or to file a complaint you may contact ACT by mail or telephone.**

## **Title VI**

### **INFORMATION YOU MAY NEED TO KNOW**

- \*Seatbelts must be worn at all times to ensure the safety of all riders. Ask the driver if you need assistance fastening your seat belt.**
- \*Parents must provide proper safety seats for children as the law states. Children under 8 years or under 80 pounds are required to have a safety seat. Children under the age of 16 must be accompanied by a parent or legal guardian**
- \*Food & Drinks are not allowed on ACT vans unless needed for a medical condition.**
- \*Weapons, tobacco products and profanity are prohibited on ACT vans.**
- \*If an attendant is required due to medical reasons, one person, acting as an attendant will be allowed to ride with the scheduled passenger at no charge. This ride must be previously arranged.**
- \*Service Animals are welcome, but must be approved by ACT personnel.**
- \*All drivers are trained to help elderly and disabled riders.**
- \*All ACT vans are equipped with Video & Audio surveillance**
- \*All vans are ADA compliant**
- \*All routes are open to the public**

All out of county trips that are more than 45 miles away must have 3 passengers with appointments or it will not be ran. Appointments must be set no later than 2:00 pm, please be prepared to stay for a while as we try to get as many passengers to a location as we can. Once an appointment is scheduled the passenger then must call the ACT office after 12:00 pm on the day before the trip to confirm and find out what time the pickup will be. Contractual obligations will be honored.

Non Medical trip scheduled with a medical: \$25.00

**Charlotte, Winston Salem: \$30.00**  
Non Medical trip scheduled with a medical: \$35.00

**Raleigh, Durham, Chapel Hill, \$40.00**  
Non Medical trip scheduled with a medical: \$45.00

**Groups of 7 or more please call the ACT office for group rates. All group trips are open to the public**

\* Medicaid Transportation is available for medical appointments or prescription medication pharmacy visits but must be pre-approved by the Department of Social Services or your Medicaid Broker (i.e. Modivcare, OneCall). If transportation is not approved or the proper paper work that is provided is not filled out and returned the passenger will have to pay for the trip. Also any stops made during a medicaid transport that are not medical related will result in the passenger paying a fee of \$1.00 per stop that is due on the day of service.

\* Any person finding it a financial burden to pay may apply for a reduced rate through one of our programs.
